

Type of Information Collected

For the purposes of using blogs, forums, and other interactive services provided on my website and/or other community platforms, I may receive, collect, and store any information you enter. This information can include Internet protocol (IP) addresses, e-mail addresses, or other information you enter. Page interactions, responses, comments, posts, personal profiles, and browsing information may be collected.

How Information Is Collected

My company is hosted by <u>wix.com</u> which provides me with a platform that enables my services for data storage, databases, and <u>wix.com</u> applications. They store and secure all of your data on their servers using a firewall. Should services be provided in the future requiring payments to be made, my company adheres to the standards set by the PCI-DSS managed by the PCI Security Standards Council to ensure your credit card information is stored securely.
